

Terms of Service

Article 1; (Application of regulations)

Those who use this club (regardless of members and guests) will use this club in accordance with this regulation in order to enjoy comfortable and safe play with each other.

Article 2; (Establishment of usage agreement)

- (1) Those who use the facilities in this club must sign the prescribed list at the front desk on the day. This club will accept the signer's use of the facility.
- (2) Members of the club must inform the accompanying guests in advance of the contents of the regulations in addition to the regulations of the club.

Article 3; (Reservation, cancellation, etc.)

Play reservations, cancellations, etc. are subject to the procedures prescribed by the club.

Article 4; (Refusal of facility usage)

The club may refuse to use or continue to use the facility in the following cases.

- (1) When the start time is not enough due to the full space.
- (2) When it is recognized that the clothing is not suitable for this club.
- (3) When an act that violates public order or good manners, or when it is recognized that there is a risk of such an act.
- (4) When the golf course is closed due to natural disasters or other unavoidable circumstances.
- (5) When taking photos, recording without permission.
- (6) In case of not stopping the indicated action despite being warned by the club in rules and manners.
- (7) When the weight of a golf bag exceeds 10.5kg.
- (8) When a companion or a referral visitor is found to be a gang, a gang member, an associate member of a gang, or other anti-social group.
- (9) When the person has a tattoo on the body, or when the act of exposing all or part of something that is misunderstood as tattooed is done.
- (10) If you have a contagious or infectious disease, or if you do not comply with the infectious disease prevention measures set by our club.
- (11) In addition, if you violate the rules and regulations established by this club, or if there are reasons that make it undesirable to use the facilities of this club.



Article 5; (Business day, business hours)

- (1) The business day and hours of the club shall be as determined by the club. However, it may change temporarily.
- (2) We may be temporarily closed due to stormy weather such as rain and snow, or due to the unavoidable circumstances of our club. In this case, no cancellation fee will be charged between the club and the reservation person.

Article 6; (Money and other expensive items)

Money and other expensive items should be stored in the designated valuables locker. The club is not responsible for accidents in the valuables locker.

Article 7; (Portable goods, automobiles, etc.)

The club is not responsible for theft or damage of golf clubs, shoes, bags and other portable items and cars parked in the facility.

Article 8; (Responsibility for risk prevention and strict etiquette manners)

- (1) Golf can be very dangerous from time to time, so players are responsible for keeping etiquette and manners, regardless of the advice of the caddie.
- (2) In principle, green casters shall use carts on golf courses and other facilities. When a player or other person drives a cart and intentionally or negligently causes damage to himself or a third party (including but not limited to employees of the Club) or the facilities of the Club, shall compensate the driver and passenger of the cart for the damage, regardless of whether green caster agrees or not.

Article 9; (Swing in the tee)

Do not perform swinging anywhere other than specified. If you are not playing, please do not enter the tee.

Article 10; (Check flying distance)

The player is fully responsible for the hit ball. Regardless of the advice given by the caddie, the player must judge his / her own distance and hit the ball so that he / she does not hit the preceding group.

Article 11; (Do not go in front of the player)

A companion must never come in front of the player.

Article 12; (Driving into the adjacent hole)

Since it is particularly dangerous to hit the adjacent hole, the player must make a proper judgment on the distance and direction of flying of his / her ball and carefully hit the ball. In the unlikely event that you hit, signal the player in that hole, hit the ball without getting in the way, and be very careful with your accompanying player.

Article 13; (Evacuation and evacuation location)

Players in the preceding group should evacuate to a safe place until the following group finishes hitting when the following group hits.

Article 14; (Leaving after a hole out)

Please leave the green immediately after the hole out, go to the next hole through a safe place against the hit from the following group.

Article 15; (In case of thunder, earthquake, etc.)

- (1) If there is a thunder, stop playing immediately and evacuate to a safe place such as a shelter.
- (2) In the event of an emergency such as an earthquake, stop playing immediately and evacuate to a safe place.
- (3) This club is not responsible for lightning strikes or earthquake damage.

Article 16; (Prohibition of use of fire)

Use of fire inside the golf course is strictly prohibited except in designated places. Be sure to put out the cigarette drums and match husks well and put them in the ashtray.

Article 17; (Responsibility in case of wrongdoing)

When a user violates Article 8, Article 9, Article 10, Article 12, or Article 16 and causes an accident such as a failure to a third party, In the event of violating Article 8, Article 9, Article 11, Article 13, Article 14, or Article 15 and suffering damage such as disability, this club will not be liable for any damages.

Article 18; (Emergency patient treatment)

Players should always give due consideration to their health. In the unlikely event of a sudden illness, the club will make every effort as much as possible, but cannot assume



responsibility for the results.

Article 19; (Confirm club after play)

Players shall check their own clubs after play, and the club will not be responsible for any wrongly damaged or lost clubs. The same shall apply if the club has not been confirmed or signed after confirmation.

Article 20; (In case damage is caused to facilities)

If damage is caused to the facilities of the club and employees of the club due to the intention or negligence of the user, the damage shall be compensated.

Article 21; (Items brought into the facility)

The following items are not allowed in the facility.

- (1) Pets
- (2) Those that give off a significant odor
- (3) Gun, sword, etc.
- (4) Volatile oil, explosives, etc. that may ignite or explode
- (5) Noise generator

Article 22; (Prohibition of conduct)

The following acts within the facility are not allowed.

- (1) Gambling and other actions that disturb the manners
- (2) Activities such as sales of goods and advertisements
- (3) Access to courses and practice areas other than users (unless specifically permitted)
- (4) Actions such as photography, recording, etc. (unless specifically permitted)
- (5) Acts that cause inconvenience or discomfort to others
- (6) Bringing food, drinks and alcohol

Article 23; (Responsibility for guest actions)

- (1) When using the facilities of the Club, the Guest shall comply with the Rules and Regulations of the Club, the rules of use, and the guidelines for use. You will be responsible for the payment of and all actions within the club.
- (2) Members who accompany guests and members who introduce guests are also subject to the rules and regulations of this club. As stipulated in the rules of use and guidance for use, in addition to the responsibilities of the guest in the preceding paragraph, you

will be responsible for the payment of the guest's contribution and other expenses for the use of the club and all actions within the club.

- (3) Notwithstanding the provisions of the preceding paragraph, the board of directors and the company shall not be held responsible for the payment of fees and other expenses for the use of the club by guests, and for any actions taken at the club.

Establishment of regulations

This regulation is effective from July 26, 1992.
